The Marriage (Amending) Law of 2017 issued by publication in the Official Gazette of the Republic of Cyprus in accordance with Section 52 of the Constitution.

Number 95(I) of 2017 LAW AMENDING THE MARRIAGE LAWS OF 2003 AND 2009

The House of Representatives votes as follows:

Short title 104 of 2003 66 of 2009.

1. This Law shall be referred to as the Marriage (Amending) Law of 2017 and shall be read along with the Marriage Laws of 2003 and 2009 (which shall be hereinafter referred to as "the basic law") and the basic law and this Law shall be jointly referred to as the Marriage Laws of 2003 to 2017.

Amendment of the First Schedule of the basic law. **2.** The First Schedule of the basic law is replaced by the following new First Schedule:
